COMMUNITY FOOD PARTNERS - PROVIDED NEARLY 21 MILLION POUNDS OF FOOD DURING 2016 (19 MILLION POUNDS IN 2015) TO NEARLY 500 NOT-FOR-PROFIT AGENCIES, INCLUDING SOUP KITCHENS AND EMERGENCY FOOD PROGRAMS. THE MIDDLE TENNESSEE'S TABLE PROGRAM COLLECTS PERISHABLE AND NON-PERISHABLE FOOD FROM 224 FOOD DONORS, SUCH AS GROCERY STORES, RETAILERS, WHOLESALERS AND BAKERIES, WHICH IS THEN DISTRIBUTED TO OUR COMMUNITY FOOD PARTNERS AND PROGRAMS. THESE PRODUCTS INCLUDE MEATS, PRODUCE, DAIRY, BREAD, BAKERY ITEMS AND DRY PRODUCTS. DURING 2016, THE FOOD BANK DISTRIBUTED OVER 11.6 MILLION POUNDS OF FOOD (EQUIVALENT TO MORE THAN 9.7 MILLION MEALS) UNDER THIS PROGRAM. (THE FOOD BANK DISTRIBUTED 10.1 MILLION POUNDS EQUIVALENT TO MORE THAN 8.4 MILLION MEALS IN 2015).
